- 1. Section 9.1.5 is amended as to add vinyl siding as an approved exterior siding material for any structure constructed in the subdivision. No other changes or alterations are hereby made to this section of the Covenants.
- 2. Each Lot hereafter built upon shall be required to sod the front yard before completion of construction and furthermore said Lots shall install an irrigation system throughout the front yard before the sod is installed subject to the approval of the Declarant or its' successors and/or assigns or in the alternative the Architectural Control Committee for the subdivision.
