SECOND AMENDMENT TO
DECLARATION OF COVENANTS,
CONDITIONS AND RESTRICTIONS,
HEADWATER COVE AT BRADLEY CREEK
(now HEADWATER COVE TOWNHOMES)

KNOW ALL MEN BY THESE PRESENTS THAT:

GTC PROPERTIES, LLC, a North Carolina limited liability company (hereinafter called "Declarant"), heretofore executed a Declaration of Covenants, Conditions and Restrictions, Headwater Cove at Bradley Creek, Phase I, and caused the same to be recorded in the New Hanover County Registry ("NHCR"), in Book 2227 at Page 0032, and an Amendment to the same recorded in Book 2383 at Page 855, NHCR (herein collectively the "Declaration"); and

WHEREAS, there were some discrepancies between the Declaration and the final plat of the subdivision recorded in Map Book Map Book 37 at Page 126, NHCR (the "Final Plat"), in that: (i) the name of the subdivision as set forth in the Declaration is "EDGEWATER COVE AT BRADLEY CREEK" and the name shown on the Final Plat is "HEADWATER COVE TOWNHOMES", and (ii) the numbering system for Lots shown on the Final Plat does not follow the numbering system prescribed by the Declaration; and

WHEREAS, the Declarant desires to correct and reconcile those discrepancies, and the Declaration provides, in Article XIII, Section 9, Paragraph C thereof, that the Declarant shall have the right to amend the Declaration, without the joinder or consent of Headwater Cove at Bradley Creek HOA, Inc. (the "Association"), or its members, the owners of individual lots in the Subdivision to correct to correct any obvious error or inconsistency in drafting, typing or reproduction;

NOW, THEREFORE, in consideration of the premises, the Declaration is hereby amended as follows:

- 1. The name of the subdivision which appears in all places in the Declaration as "HEADWATER COVE AT BRADLEY CREEK PHASE I" is hereby changed to read "HEADWATER COVE TOWNHOMES"
- 2. The description of the Properties set forth in the preambles and elsewhere in the Declaration is hereby deleted and in its place, and in lieu thereof, the following description of the Properties shall be substituted and subjected to the Declaration:

Being all of Lots 1A, 1B, 1C, 2A, 2B, 2C, 3A, 3B, 3C, 3D, 7A, 7B, 7C, 7D, 8A, 8B, 8C, 8D, and 8E as shown on the plat entitled "HEADWATER COVE TOWNHOMES, recorded in Map Book 37 at page 126 of the New Hanover County Registry.

The foregoing amendment shall run with the real property and be binding on all parties, their heirs, successors and assigns, having any right, title or interest in any lots in Headwater Cove Townhomes (formerly Headwater Cove at Bradley Creek, Phase I), or any part thereof, and shall inure to the benefit of each owner thereof.
