AMENDMENT TO DECLARATION OF COVENANTS, COMDITIONS
AND RESTRICTIONS OF
PEPPER TREE AT COVIL ESTATES

WHEREAS, in accordance with ARTICLE X, Section 1, of said Declaration, the Declarant has the absolute right to develop additional lands contiguous to Pepper Tree at Covil Estates and to annex the same to Covil Estates without the joinder or assent of the Class A members of Pepper Tree at Covil Estates, by an amendment to the Declaration; and,

WHEREAS, the Declarant does hereby amend the Declaration and declares that all of the property described above shall be held, sold and conveyed subject to the same easements, restrictions, covenants, and conditions as are applicable to Pepper Tree at Covil Estates, Section 3, as more fully described in the Declaration which is hereby incorporated herein by reference and made a part hereof as though fully set out verbatim herein, but subject to the following changes:

ARTICLE I. Section 5 is modified by adding to the description of the common areas, the following:

BEING all of the common area on the map of SECTION 3, PEPPER TREE AT COVIL ESTATES, recorded in Map Book 35, Page 192 of the New Hanover County Registry.
